We will encourage positive behaviours: try new things, concentrate, push yourself, understand others, work hard. We will encourage pupils to foster a Growth Mindset. We will contact parents/carers if we are concerned about pupils' behaviour. We will reward good behaviour. 	 We will support the school policies that promote good behaviour. We will attend meetings to discuss our child's behaviour if invited by the school. We will regularly log-in to ClassDojo. We will celebrate successes with our child. 	 I will behave well and follow the school rules. I will demonstrate a Growth Mindset. I will demonstrate learning behaviours including; try new things, work hard, concentrate, push yourself. I will talk to an adult if I am having any problems in school. I will feel proud of my own and others' achievements.
